\*\* Jumper classes will be scored by time including fault penalties. Gambler's Choice class points accrued in time allotted. Rider cannot jump the highest value jump successively.

**Apparel** - ASTM/SEI approved helmets required while mounted. Show attire is encouraged, but not required. Mounts should be well-groomed, reflecting regular care. Tack should be safe, clean and well adjusted, reflecting regular care.

**Arenas**- All outdoors: One (1) large Dressage arena sand footing, warm-up arena with sand footing, Jumper arena fenced grass, jump warm up, grass

**Awards** - Combined Tests, Dressage Tests and Jumper classes will be judged and places through 6th place.

**Stabling** – Permanent stabling facilities with 10x10 & 12x12 stalls available. \$20 per stall. Bagged bedding available \$5 a bag at show (please let us know how many you'll need) Stalls must be cleaned before your departure.

**Miscellaneous** - All dogs must be kept on a leash. No Stallions
